Contamination Declaration

9. Legally Binding Declaration:

We hereby certify that the above information is complete, accurate, and has been provided following a professional review. This declaration covers all substances, hazardous materials, operating fluids, residues, reaction products, process materials, and other contaminants with which the product has come into contact, or may have come into contact, either as intended or in practice. We are aware that Infracerv Vakuumservice GmbH uses this information as the basis for the acceptance, storage, handling, inspection, cleaning, maintenance, and repair of the product.

We further confirm that the undersigned is professionally qualified to assess the contamination and is legally authorized or duly empowered to issue this declaration on behalf of the sending company.

We confirm that the product was properly emptied, secured, sealed, packaged, labeled, and, where necessary, classified and shipped in accordance with the applicable legal regulations governing transport, hazardous substances, and dangerous goods prior to shipment. All openings, in particular inlet and outlet flanges, are sealed vacuum-tight with suitable stainless steel blind flanges. To the extent that operating fluids, residual materials, residual water, oils, or other residues remain in the product, these are fully and accurately specified.

Products without a fully completed and legally binding signed contamination declaration, as well as products that are not properly secured, may be rejected, held, stored separately, returned at the customer's expense and risk, or processed only after clarification, inspection, cleaning, or decontamination by Infracerv Vakuumservice GmbH. Infracerv Vakuumservice GmbH is not obligated to open, inspect, or repair a product that has been inadequately declared or inadequately secured.

We are liable to Infracerv Vakuumservice GmbH for all damages, expenses, and additional costs arising from incorrect, incomplete, delayed, or omitted information, or from insufficient emptying, cleaning, securing, packaging, labeling, or declaration. This includes, in particular, costs for quarantine, special storage, safety measures, internal and external inspections, cleaning, decontamination, business interruptions, disposal, additional personnel expenses, return transport, experts, communication with authorities, as well as legal prosecution and defense.

We indemnify Infracerv Vakuumservice GmbH against all claims by third parties arising from incorrect, incomplete, late, or omitted information, or from inadequate emptying, cleaning, securing, packaging, labeling, or declaration of the product. This indemnification covers carriers, in particular service providers, claims by employees, government agencies, workers' compensation associations, social security agencies, and other third parties. The customers' legal liabilities, in particular toward third parties and government agencies, remain unaffected by this.

If the product is not being returned by the original operator or end customer, but rather by an intermediary, reseller, service partner, or other third party, the sender hereby confirms in a legally binding manner that they have verified the end customer's contamination information, are adopting this information as their own when providing it to Infracerv Vakuumservice GmbH, and are responsible for its accuracy, completeness, and currency. The sender further confirms that they are not aware of any circumstances that would render the end customer's information inaccurate, incomplete, or outdated, and that since the product was received, no additional contamination, openings, modifications, cleaning, or other procedures relevant to acceptance, transport, handling, or repair have taken place without these having been fully disclosed. The liability, cost, and indemnification provisions of this declaration also apply directly to the submitting distributor in relation to Infracerv Vakuumservice GmbH.

If submitted electronically, the declaration must be issued by a person from the submitting company who can be identified by name and is authorized to make the declaration. Infracerv Vakuumservice GmbH is entitled, in the event of unclear attribution, lack of authorization, incomplete information, or other doubts, to request a new declaration, a separate confirmation, or a declaration with a qualified electronic signature, and to suspend processing until the matter is clarified.

Supplementary Sheet

This supplementary sheet is intended to assist you in completing the contamination declaration.

The intention is to ensure that all relevant information is provided in a complete, clear, and accurate manner. Only on this basis can the product you have sent in be safely accepted, handled, maintained, or repaired.

Incomplete or incorrect information may result in personal injury, delays in service, as well as additional costs or legal consequences.

Please note the following points when completing the contamination declaration:

1. Type of Product:
Please describe the product submitted in detail. This serves, first, to clearly link the contamination declaration to the product. Second, in the case of operating fluids (oils), it is important that they are not mixed, as this would cause them to lose their viscosity. It is also important for us to know whether there are any residues of the operating fluid remaining in the product.
2. The reason for the submission helps us with our internal processing.
3. Contamination resulting from Use:
Please specify the basic hazards posed by the product here.
4. Sealing:
This field is for verification purposes. All products must be sealed vacuum tight with stainless steel blanking flanges before shipping.
5. a. Processes with which the product came into contact:
A brief description of the process helps to narrow down the potential hazards more precisely.
5. b. It is essential to provide a list of all substances. This includes, for example, solid materials that were present in the chamber, such as wafers from which particles may have been released (e.g., during etching processes). Please also list any possible reaction products.
6. If there are **no hazardous substances** in the product, check the appropriate box, but still list all substances.
7. Copper:
Some processes are highly sensitive to copper particles. Therefore, there are separate processes for products that must not come into contact with copper. Please check "No" only if this is critical for your production and the presence of particles is absolutely impossible.

Products that are not properly declared or packaged cannot be accepted.
